Resolution #24-03 Approval of Financial Assistance of up to \$891,496 from the Redevelopment Investment Fund (RIF) to 49-55 Central Ave Holdings LLC

Board Member Anthony Findley noticed that there was nothing in the project cost for environmental. NJRA COO Darryl Godfrey responded that this project is a refurbishment of a standalone building. There is no environmental concern with this project.

Chairman Kia King said she is excited about this project and its proximity to an urban park.

Board Member Aimee Manocchio Nason asked about the relationship of The Eminence Group to this project and their stake in the property. NJRA COO Darryl Godfrey responded that The Eminence Group will be the purchaser of the property and the developer Lamont Carter is the 100% owner of The Eminence Group.

Resolution #24-04 Approval of Financial Assistance of \$1,000,000 from the Redevelopment Investment Fund to Gateway Lofts Urban Renewal LLC

Board Member Anthony Findley expressed his pleasure that more than half of the units are affordable units. He also asked does the project have Low Income Housing Tax Credits in it and what are the Newark House Funds.

NJRA President and CEO Leslie A. Anderson said that the Newark House funds come from the City of Newark. These are a source of Federal Funds that come from HUD and because of its side, Newark gets its own allocation.

Board Member Anthony Findley said he was impressed that all of the units in this project are

affordable and that there is electric vehicle parking. NJRA COO Darryl Godfrey said that electric vehicle parking is a priority of Chairman King. Chairman Kia King said that the priority of electric vehicle charging is truly about environmental justice. She is also happy to see the disability access space. NJRA President and CEO Leslie A. Anderson said that you do not always see electric vehicle charging stations in urban areas. The NJRA wants to be at the forefront of bringing this type of technology to urban areas.
